Payment and Cancellation Policies:

You are responsible for the full payment of any fees incurred during your visit to Dr. Olena Gill, ND at the end of each visit. We require **at least 24 hours notice**, if you wish to cancel or reschedule an appointment or **you will be charged for the time set aside and the specific cost toward that time and treatment type** and, in the case of a scheduled treatment, the cost of non-reusable products prepared for you. Notice of cancellation or rescheduling must be given during regular clinic hours. Email Cancellations are NOT Accepted. You **MUST** call the office at 778-762-3099.

- ~ It is Office Policy that cc information will be kept on file, after the first visit, in the event of Missed or No Show fee billing (Policies are laid out in our Office Policy & Fee sheet which is mandatory to sign prior to your first visit)
- ~ We accept payments in cash, cheque, MasterCard, Visa, American Express, or Interac. NSF cheques will incur a \$15 fee
- ~ Outstanding accounts need to be finalized prior to booking subsequent appointments
- ~ You will receive a receipt after every visit. Please ensure that you save these to submit to your Extended Health service provider if appropriate

To speed up the time it takes to process this at the end of your visit, please ensure you disclose your health insurance ID and info at the beginning of your first visit, and to determine whether you qualify for insurance billing
